Explanation of Responses:

- These transactions reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on May 1, 2019.
- Includes 276 shares acquired under the Issuer's Employee Stock Purchase Plan on November 30, 2019.
- Represents the weighted average sale price per share. These shares were sold in multiple transactions at prices ranging from a low of \$59.78 to a high of \$60. The Reporting Person undertakes to provide to the Issuer, any security holder of the Issuer, or the staff of the Securities and Exchange Commission, upon request, full information regarding the number of shares sold at each separate price.
- The option vested 25% one year from the grant date of 8/3/2016, and an additional 6.25% vested at the end of each three-month period through 11/3/2019. The remaining shares subject to the option will vest at 6.25% at the end of each three-month period until fully vested on 8/3/2020.

Remarks:

The Reporting Person acquired 0.0761 shares of the Issuer's common stock under a reinvestment feature of the Issuer's 401(k) plan since his last filing. The reported indirect holdings are based on shares held under the Issuer's 401(k) plan as reported on November 1, 2019.
