1. Represents the weighted average sale price per share. These shares were sold in multiple transactions at prices ranging from a low of \$48.88 to a high of \$49.19. 2. The option vested 25% on the first anniversary of the grant date and 6.25% at the end of each three-month period thereafter.
3. The option vested 25% on June 30, 2008 and 6.25% at the end of each three-month period thereafter.
4. The option vested 25% one year from the grant date of 11/10/2011. The remaining shares subject to the option will vest at 6.25% at the end of each three-month period until fully vested on 11/10/2015.
5. The option vested 25% one year from the grant date of 11/11/2010, and an additional 6.25% vested at the end of each three-month period through 11/11/2012. The remaining shares subject to the option will vest at 6.25% at the end of each three-month period until fully vested on 11/11/2014.
6. The option vested 25% one year from the grant date of 11/11/2009, and an additional 6.25% vested at the end of each three-month period through 11/11/2012. The remaining shares subject to the option will vest at 6.25% at the end of each three-month period until fully vested on 11/11/2013.
